### DO I NEED TO BE A MEMBER TO PARTICIPATE IN NATA'S SUSTAINABILITY STANDARD?

Participation is limited to NATA member organizations. If you are interested in NATA membership, please click <u>here</u>.

#### HOW MUCH DOES IT COST TO GET THE CERTIFICATION?

Participation is free of charge.

### WILL NATA AUDIT COMPANIES THAT SUBMIT THE CHECKLIST FOR CERTIFICATION?

No. Upon receipt of the required documents, NATA will evaluate the submission prior to providing confirmation. Although this is a self-certification, NATA may request verification of any items (solely for proposes of confirming conformance to this Standard and issuing certificate).

### WILL NATA COLLECT CARBON FOOTPRINT METRICS FROM CERTIFIED AVIATION BUSINESSES?

No. Although the checklist requires that the applicant calculate its carbon footprint, the actual score does not need to be disclosed to NATA for the purposes for obtaining this self-certification. Organizations are not required to submit or disclose any confidential materials.

- Add the Tier 1 items......Green Aviation Business Tier 1
- Add the Tier 2 items......Green Aviation Business Tier 2

# WHAT HAPPENS AFTER I SUBMIT MY COMPANY'S CHECKLIST?

Once an organization completes and submits a signed checklist, and NATA accepts the application, NATA will issue a certificate and logo for the applicable year. Within the next 48 hours, you will be able to visit our NATA Sustainability Standard Certified <u>directory</u> on our website and see your facility/facilities proudly displayed.
